

Projects Features

Removal and replacement of the existing Gymnasium Building M-100 gym floor and sub floor. The existing wood floor will be sanded down, and any poor or damaged sections will be replaced. The game lines will be repainted and restriped to include NCAA men's and women's basketball game lines on the main court, as well as volleyball lines for one main court and two practice courts. Additionally, lines for six badminton courts will be added. A new school logo, measuring 6 feet by 8 feet, will be installed at center court.
