This policy enumerates all mandatory and optional student fees authorized by statute.

#### 1. MANDATORY FEES

The following fees are mandated by state law and are charged to students as a condition of enrollment.

- a. ENROLLMENT FEES shall be charged to all students who enroll in college credit classes as follows:

- 1) The fee charged shall be forty-six dollars (\$46.00) per unit. ~~Half units shall be charged at twenty-three dollars (\$23.00).~~
- 2) The charges above shall be determined using the highest cumulative number of units during any semester, intersession, summer session, or term.

~~3) Students receiving credit by examination shall be charged forty-six dollars (\$46.00) per unit, consistent with the enrollment fee.~~

- b. NONRESIDENT TUITION shall be assessed of all college students who are classified as nonresidents in accordance with BP and AP 5015 Residence Determination (Education Code section 68000, et seq.). The fee shall be \$304.00 per unit or fraction of a unit for all college classes.

- c. BACCALAUREATE DEGREE PROGRAM FEES shall be charged to students for all upper division coursework.

- 1) The fee shall be eighty-four dollars (\$84.00) per unit in addition to the enrollment fee of \$46.00 per unit.
- 2) Nonresident students shall be charged the eighty-four dollars (\$84.00) per unit in addition to the enrollment fee of \$46.00 per unit, and the nonresident tuition fee of ~~\$304~~331.00 per unit.

~~d. INTERNATIONAL STUDENT APPLICATION FEE of \$100.00 shall be charged to all students who are residents and citizens of a foreign country. The fee is non-refundable and will be credited toward nonresident tuition when the student registers (California Education Code, Section 76142).~~

~~e.d.~~ REFUNDS in full are authorized when a student officially withdraws before the refund deadline:

- 1) The refund deadline is determined by the length of the session. ~~For Primary 16-week session the deadline shall be the Friday of the second week of the session. Refund deadlines for Summer classes and all classes in non-primary sessions in Fall and~~

- 2) When a reduction in units of enrollment results from an action of the district to reschedule or cancel a class, students automatically receive a refund in the mail or credit to their credit cards. -Refunds will be automatically sent to students after the add/drop deadline. -After the second calendar week of instruction, fees may be transferred from one course to another due to movement up or down in a subject area, or change in schedule due to circumstances beyond the control of the student.

- 1) The fee will include health services and accident insurance.

2) The ECC health fees are for credit college classes.

2)3) The following students exempt from the health fee:

- a) Students who meet the income standards for California College Promise Grant (CCPG-A only).
- b) Students attending only apprenticeship classes under an approved apprenticeship program, enrolled in only apprenticeship courses.
- c) Students who depend on prayer for healing, in accordance with the teachings of a bona fide religious sect, denomination, or organization.

Refund of the health fee shall be consistent with the district's refund policy.

STUDENT REPRESENTATION FEE is assessed of all students enrolled in at least one credit college class for the purpose of (1) Student Senate of California Community Colleges (SSCCC) and (2) student advocacy efforts to federal, state and local governments (California Code of Regulations, Title 5, Sections 54801-54805).

Refund of the representation fee shall be consistent with the district's refund policy.

Students have the right to refuse to pay the fee for religious, moral, political or financial reasons (California Code of Regulations, Title 5, Section 54805).

#### h.g. **COLLEGE OF CONTINUING EDUCATION (CE) CLASS FEES**

- 1) Course fees for all community education classes will range from \$5.00 per student per instructional hour to \$20.00 per student per instructional hour depending on the full cost of instruction for the class. -The full cost of instruction includes: program management, marketing, facilities, custodial, and ADA accommodations.
- 2) No fee class shall be offered unless specifically approved by the Board. Fees for the entire term of the class shall be paid at the time of registration.
- 3) The number of paid fees required to open a class, shall vary based on the cost of instruction.
- 4) A refund will be made if Community Education cancels a class or is unable to continue the class.- If the student requests a refund at least three (3) business days prior to the start of the class, a full refund will be granted.- There are no other refunds beyond the three (3) day period.
- 5) Students enrolling later than the first class session shall pay the full class fee.
- 6) Additional fees collected over the minimum shall be allocated to cover indirect program costs.
- 7) Auditing or visitors shall not be permitted.
- 8) Administrative time and cost to implement and supervise the fee classes shall be kept to an absolute minimum.

#### h.h. **TEST PROCTORING SERVICES FEES**

- 1) Up to 4 hours: \$50.00
- 2) More than 4 hours: \$100.00

The fee will be waived for any student currently enrolled in a California community college.

Per California Department of Education (CDE) and California Department of Social Services (CDSS), Enrollment, Attendance, and Fiscal Reporting, and Reimbursement Procedures FY 2022-23:

- "When determining the rate to collect from non-certified families, contractors must take their ability to collect funds from other sources into consideration, as earnings and payment calculations performed by [Early Education and Nutrition Fiscal Services] EENFS will not allow State funds to be utilized for non-certified families. Contractors should keep in mind that the greater the difference between their contract rate and the non-certified fee, the greater the deficit. In addition, the ratio of certified to non-certified children must be considered; the greater the percentage of non-certified children, the greater the potential deficit, if the contract rate is greater than the non-certified fee. It must be understood that if contractors choose to collect a fee from non-certified children that is less than their contracted rate, and if there is no outside fund source to cover the cost of non-certified children, the deficit caused by a lesser fee will in turn result in an encroachment on the contractor's general fund and/or preschool reserve funds, or will result in the need for the contractor to obtain funding from a source other than the early education contract."

- Are charged on a monthly rate and are based on the number of hours a child is scheduled to attend on a daily basis.
- One daily rate must be selected and multiplied by the number of operating days in the month:
  - o Full-time fee is 4.0 or more hours a day and include all operating days in the month.
  - o Part-time is for less than 4.0 hours a day and include all operating days in the month.
- Cannot mix daily rates or pro-rate for absent or non-scheduled days.
- Offers a 15% sibling discount. Discount is applied to the child with the lowest cost of care.

#### m. CUSTOMER SERVICE FEE SCHEDULE

San Diego Community College District Policy 6100 authorizes the repair, fabrication, construction, or provision of services to customers as an integral part of vocational classes. It is at the sole discretion of the department to accept projects based on the approved curriculum of the program.

Costs to the District which are not convenient to itemize are recovered through charges listed in the following fee schedule. -Total cost to customers includes the listed fee plus itemized materials taken from District stock supplies and purchases from outside vendors.

Breakage, loss, or other damage to the customer's property, which occurs while the educational service is being performed or as a cause of the service, is solely the responsibility of the customer.

The customer agrees to release the San Diego Community College District (SDCCD) and the college/center, its officers, agents and employees from any claims, demands, losses, or expenses which arise from any circumstance derived from the service rendered.
